4. UPDATES AND REPORTS

Update on Napa County Groundwater Program activities and availability of Annual Groundwater Monitoring Report for 2017 (Staff) (10 min)

Patrick Lowe provided an update on the program's activities and recent reports. He presented a handout that summarized the County's annual groundwater monitoring report for water-year 2017, which included findings from a Northeast Napa Area Special Study.

The special study recommended establishing a Northeast Napa Management Area to better manage and protect groundwater resources in an area just north and east of the City of Napa. The 2017 report was the first annual report prepared to also meet the County's requirements under the Sustainable Groundwater Management (SGMA) Act. The Department of Water Resources is still reviewing alternative groundwater sustainability plans submitted to the State back in late 2016. The 2017 annual report includes not only groundwater monitoring results and conditions, but also describes management actions taken under SGMA. On March 20th the Board of Supervisors accepted the 2017 report, approved its submittal to DWR, and approved establishment of a Northeast Napa Groundwater Management Area (along Silverado Trail north and south of the Petra Dr. area). The area will be watched more closely and new projects will need to conduct more rigorous water availability studies. The full report and related information can be found on www.napawatersheds.org/groundwater. Staff demonstrated how to access the materials online using the WICC website.

Mr. Lowe was asked about the installation of additional dedicated surface/groundwater (SW/GW) monitoring wells. The County is looking for grant funding to install more SW/GW wells and is also waiting to hear back from the State DWR regarding what additional information is needed to determine/map groundwater dependent ecosystems and what management actions might be needed to protect them.

5. Presentations and Discussion:

a) Presentation and discussion on the Regional Water Board's General Permit for Vineyard Properties in the Napa River and Sonoma Creek Watersheds (Michael Napolitano and Jim Ponton, S.F. Bay Regional Water Quality Control Board) (30 min)

David Graves introduced Mr. Napolitano; who provided some background on himself and his role at the Waterboard. He noted that the Napa River sediment TMDL project began 19 yrs. ago. Mr. Napolitano presented a summary of the Vineyard Properties Permit, the Waterboard's adoption of the permit in July of last year, how landowner outreach is going, what the timeline is through December 2018, and answered questions from the Council. Mr. Napolitano described reasons for and the development of the Total Maximum Daily Load (TMDL) for Sediment in the Napa River. The TMDL is essentially a water quality improvement plan to reduce the amount of fine sand in the river to improve salmon spawning habitat. Vineyards and unpaved roads were identified as land uses in the watershed that were contributing excessive sediment and sand into the river system. The Vineyard Properties General Permit, was developed to regulate and document management practices and aid in the recovery of the river. The permit applies to parcels with \geq 5 acres of vineyard and requires vineyard owners to develop and implement farm water quality plans in accordance Waterboard regulations and certification timeline. The permit also applies to properties in the Sonoma Creek watershed. The permit includes vineyard properties that are not covered under Napa County's Conservation Regulations. Mr. Napolitano provided a handout that summarized the permit requirements and where one can find more information or help. Additionally, a fact sheet is being developed and will be available soon. The permit has a 10yr timeline to achieve performance standards. The Waterboard will continue to offer a variety of grants to implement erosion control projects. The permit also helps to control pesticides and nutrients. Mr. Napolitano noted that most (>90%) of the Napa Valley vineyards are already meeting standards for pesticides and nutrients by owners will need to document their practices. The 2017 fires had delayed outreach and workshops related to the permit. Properties that were within the perimeter of the burn area were given an additional year to comply with the permit's regulations. Post fire water quality and run-off monitoring has shown little affect from the fires, due in large part to the huge effort that took place to protect local streams and waterways from burn-area runoff during rainstorms. Only "qualified professional" can signoff on a farm plan. The Waterboard will receive annual reporting from vineyard owners and is responsible to follow up on properties that are not meeting the performance standards. There will be annual enrollment costs and \$1-\$1.50 per planted acer fee. Implementation on the valley floor will be a minimal additional cost. Implementation on the hillsides will be more to address road network (\$30,000

per mile of road). Landslides and legacy unpaved roads associated with uses prior to vineyards can be large contributors to erosion/sedimentation. Permit enrollment is expected to be open in late April. Participation in a group monitoring program and evaluation of a management practices will be key ways to ensure the performance of the permit/program. Workshops are being planned for late April.

b) Presentation and discussion on Ecological Monitoring and Recovery on Land Trust Preserves Impacted by the North Bay Fires - With Emphasis on Fire-Adapted Native Plant Communities (Mike Palladini, Land Trust of Napa County) (30 min)

Mr. Palladini was not able to attend. His presentation will be rescheduled.

c) Presentation and discussion on Measure A Funded Projects in the Putah Creek/Berryessa watershed (Chris Silke, Napa County Public Works) (20 min)

Jeff Sharp introduced Chris Silke, who provided an overview of the Lake Berryessa Watershed Improvement Program, the goals of the program, highlights of recent projects and what the future holds for additional projects/improvements. The Measure A Ordinance (Expiring June 2018) resulted in a ½% sales tax, Lake Berryessa allocation amounts to about 7% of the annual collection, or \$2.3M. Individual projects that address environmental challenges in the watershed (algal blooms, invasive species, water quality runoff, habitat restoration, ...) are funded through a competitive grant program on a revolving basis under a memorandum of understanding (MOU) with the County Board of Supervisors. Round 1 of project funding was offered in 2017. Round 2 call for projects is expected in July 2018. Types of projects included in Round 1 were: Agricultural Watershed Improvements, Stormwater Runoff Management, Invasive Species Control, Natural Wetland Buffer Creation, Water Quality Restoration, and Watershed Protection Activities. Projects that were funded in Round 1 include: Oat Hill Mine Road Erosion and Sediment Control, Upper Hunting Creek Restoration, McLaughlin Reserve Site 1 and 2. Mr. Silke answered questions from the Council. Mr. Silke mentioned the involvement of the Solano County Water Agency via their interest in lake water quality and participation in the Westside Sacramento Integrated Regional Water Management (IRWM) Group. The Westside IRWM Group is in the process of updating the IRWM Plan. Region 5 Waterboard, which includes the Berryessa/Putah Creek watershed is under an Irrigated Lands Regulatory Program. Regular water quality testing of irrigated lands is conducted. No issues from lands in Napa County was detected under the program.

The County Planning, Building and Environmental Services Department will be publishing an environmental document and revised Climate Action Plan for public comment in late June. Doris Gentry announced that the City of Napa approved water service to the Carneros Inn to help with the water issues related to the resort.

Ryan Gregory announced the North Bay Watershed Association's upcoming watershed conference on April 6th.

Geoff Ellsworth announced an upcoming watershed symposium at Napa Valley College on May 17th. Gary Kraus provided and update on various bridge work taking place in Calistoga, including removal of the instream foot-crossing.



Update on LAFCO Countywide Water and Wastewater Municipal Service Review (Brendon Freeman, Local Agency Formation Commission) (10 min)

Municipal Service Review (MSR) Overview

MSRs can be agency specific, service specific, or region specific

Purpose of MSRs

- Collect data to better understand municipal services and providers
- Enhance coordination and understanding among agencies
- Planning for infrastructure
- Coordinate services and land use
- Develop strategies to improve service provision and lower costs
- Prerequisite to sphere of influence amendments/updates, outside boundary service extensions, jurisdictional boundary changes, governance structure changes, etc.

MSRs must include determinations and/or recommendations for all of the following (CA Government Code §56430):

- 1. Growth and population projections
- 2. Location and characteristics of disadvantaged unincorporated communities
- 3. Present and planned capacity of public facilities, adequacy of public services, and infrastructure needs or deficiencies
- 4. Financial ability of agencies to provide services
- 5. Status of, and opportunities for, shared facilities
- 6. Accountability for community service needs, including governmental structure and operational efficiencies
- 7. Any other matter related to effective or efficient service delivery, as required by commission policy
- 8. Relationship with regional growth goals and policies (local policy)
