
#### Introduction

Under the Sustainable Groundwater Management Act (SGMA), sustainable groundwater management must consider interests of all beneficial uses and users of groundwater. As a result, groundwater planning and management needs to consider effects to stakeholder groups in or around the groundwater basin with overlapping interests. These interests include, but are not limited to, holders of overlying groundwater rights (including agriculture users and domestic well owners), public water systems, local land use planning agencies, environmental users, surface water users, state and federal government, California Native American tribes, and disadvantaged communities (Water Code 10723.2).

State regulations also require the development of documentation (a communication engagement plan) of opportunities for public engagement and active involvement of diverse social, cultural, and economic elements of the population within the groundwater basin. Expertise of local stakeholders may increase the chance that the best available information and best available science is being applied to make groundwater management decisions.

#### Objectives

- Provide clear descriptions of the decision-making process
- Provide opportunities for community engagement and input
- Encourage active involvement of stakeholders from diverse social, cultural, and economic backgrounds
- Include a method of progress reporting regarding groundwater sustainability, groundwater conditions and projects, and management actions taken
